- Not be in bankrupt status.

Other persons excluded from being appointed or elected as a director include employees and those who have an interest in a contract with Let's Talk Science.

Directors must fulfill the requirements and responsibilities of their position, for example, preparing for and attending board/committee meetings, and Directors upholding their fiduciary obligation to the corporation, are required to sign a Declaration confirming their agreement to adhere to their fiduciary duties and Board policies.
